



Enrollment Process for Independent Beachbody® Coaches Seeking Military Waiver

Beachbody is proud to offer the military waiver program to qualified Coaches. Beachbody offers this waiver of our standard enrollment fee (\$39.95 plus tax) and the monthly Business Service Fee (\$15.95 plus tax) to service members enrolled as Independent Beachbody Coaches. Those eligible include active duty service members, spouses of active duty service members not already enrolled as a Coach, honorably discharged military veterans (including those discharged early as a result of injuries sustained in the course of service), and spouses of military service members who were lost or killed in action.

For qualified individuals who are already enrolled as an Independent Beachbody Coach and not yet taking advantage of the military waiver, please submit proof of your qualification to our Coach Relations department via fax (213-201-7225) or via email (coachrelations@teambeachbody.com). Acceptable documents include (a) a copy of your active duty orders, (b) a copy of a recent LES which confirms your current assignment and end date of current orders, (c) a copy of your BIR or (d) a copy of your DD214. Please note we **will not** accept a copy of your military ID as proof of your eligibility. Once your documents are received and reviewed, your future business service fees will be waived. If you submit paperwork within 30 days of your enrollment with Beachbody, your standard enrollment fee (\$39.95 plus tax) will also be refunded.

For individuals who have not yet enrolled as a Coach, please complete your online enrollment as a Coach, and once your account has been created, please submit your military paperwork to Coach Relations following the guidance in the paragraph immediately above. For your convenience, page two of this document can be used as a fax cover sheet you can use for your submission.

If you are submitting paperwork for the military waiver and the paperwork submitted is expired, incomplete or in some form incomplete, our Coach Relations team will reach out to you directly to request additional information. Military Waiver Request

Once you have enrolled as an Independent Beachbody Coach and wish to apply for our military waiver, please provide confirmation of your status, as noted in the attached instruction sheet. ***Please note that under no circumstance will we accept a copy of your military ID in order to qualify for this waiver.*** Documents may be submitted via fax using this cover sheet, or via email at coachrelations@teambeachbody.com. Once paperwork has been reviewed, you will receive further confirmation of the waiver acceptance via email. If additional paperwork or information is required in order to complete this process, a Coach Relations agent will contact you directly.
